Another Dearborn Partners Core Rising Dividend SMA Portfolio Increase: American Tower Corporation

On May 27, 2021, American Tower Corporation (AMT) announced an increase in the Company's quarterly cash dividend per share to \$1.27 (\$5.08 annually) up 2.4% from the \$1.24 per share (\$4.96 annualized) paid last quarter, and up 15.5% from the from \$1.10 (\$4.40 annualized) paid a year earlier. The cash dividend will be paid on July 9, 2021 to holders of record as of June 18, 2021. American Tower has increased its dividend each quarter for more than nine consecutive years.

American Tower, one of the largest global REITs, is a leading independent owner, operator and developer of multitenant communications real estate with a portfolio of approximately 187,000 communications sites.

American Tower Corporation is in the Real Estate sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 26 of 49 companies in our Core Rising Dividend portfolio have announced 27 dividend increases averaging about 10.3% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
