Another Dearborn Partners Core Rising and High & Rising Dividend SMA Portfolio Increase: Realty Income Corporation

On June 15, 2021, after only one quarter, Realty Income Corporation announced an increase in the Company's common stock monthly cash dividend per share to \$0.2355 (\$2.826 annually) to be paid July 15, 2021 to shareholders of record as of July 1, 2021. This newly declared dividend is up 0.2% from the \$0.235 (\$2.82 annually) paid last quarter, and up 0.9% from \$0.2335 (\$2.802 annually) paid the previous year.

From the Press Release: "We remain committed to our company's mission of paying dependable monthly dividends to our shareholders that increase over time," said Sumit Roy, President and Chief Executive Officer of Realty Income. "Our Board of Directors has once again determined that we are able to increase the amount of the monthly dividend to our shareholders, marking the 111th increase since our company's public listing in 1994. With the payment of the July dividend, we will have made 612 consecutive monthly dividend payments throughout our 52-year operating history."

Realty Income, The Monthly Dividend Company®, is an S&P 500 company dedicated to providing stockholders with dependable monthly income. The company is structured as a REIT, and its monthly dividends are supported by the cash flow from over 6,600 real estate properties owned under long-term lease agreements with commercial clients. To date, the company has declared 612 consecutive common stock monthly dividends throughout its 52-year operating history and increased the dividend 111 times since Realty Income's public listing in 1994 (NYSE: O). The company is a member of the S&P 500 Dividend Aristocrats® index.

Realty Income Corporation is in the Real Estate sector of both of our Dearborn Partners Rising Dividend separately managed account (SMA) portfolios. So far this year, 27 of 49 companies in our Core Rising Dividend portfolio have announced 29 dividend increases averaging about 10.1% more than these companies paid a year earlier. In our High & Rising Dividend Portfolio, 13 of 25 companies have announced 14 dividend increases averaging about 5.6% more than these companies paid a year earlier. No companies in these portfolios have reduced or suspended dividends so far this year.
