Another Dearborn Partners Core Rising Dividend SMA Portfolio Increase: STERIS plc

On August 9, 2021, STERIS plc (STE) announced a 7.5% increase in its quarterly dividend per share to \$0.43 (\$1.72 annually) from \$0.40 (\$1.60 annually). The cash dividend will be paid on September 24, 2021 to holders of record as of September 3, 2021. This is the 16<sup>th</sup> consecutive annual increase in the dividend paid by STERIS plc.

STERIS's mission is to help its customers create a healthier and safer world by providing innovative healthcare and life science products and services around the globe.

STERIS plc is in the Health Care sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 30 of 49 companies in our Core Rising Dividend portfolio have announced 33 dividend increases averaging about 9.9% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
