Another Dearborn Partners Core Rising and High & Rising Dividend SMA Portfolio Increase: Verizon Communications, Inc.

On September 2, 2021, Verizon Communications, Inc. announced a 2% increase in its quarterly dividend per share to \$0.64 (\$2.56 annually) from \$0.6275 (\$2.51 annually). The cash dividend will be paid on November 1, 2021 to holders of record as of October 8, 2021. This is the 15th consecutive annual increase in the dividend paid by Verizon Communications, Inc.

From the Press Release: "Consistency of dividend increase reflects Board's confidence in service revenue growth and multi-purpose network strategy."

Verizon Communications Inc. (NYSE, Nasdaq: VZ) was formed on June 30, 2000 and is one of the world's leading providers of technology, communications, information and entertainment products and services. Headquartered in New York City and with a presence around the world, Verizon generated revenues of \$128.3 billion in 2020. The company offers data, video and voice services and solutions on its award-winning networks and platforms, delivering on customers' demand for mobility, reliable network connectivity, security and control.

Verizon Communications, Inc. is in the Communication Services sector of both of our Dearborn Partners Rising Dividend separately managed account (SMA) portfolios. So far this year, 33 of 49 companies in our Core Rising Dividend portfolio have announced 36 dividend increases averaging about 9.9% more than these companies paid a year earlier. In our High & Rising Dividend Portfolio, 15 of 25 companies have announced 16 dividend increases averaging about 5.5% more than these companies paid a year earlier. No companies in these portfolios have reduced or suspended dividends so far this year.
