Another Dearborn Partners Core Rising Dividend SMA Portfolio Increase: Atmos Energy Corporation

On November 10, 2021, Atmos Energy Corporation (ATO) announced an 8.8% increase in its quarterly dividend per share to \$0.68 (\$2.72 annually) from \$0.625 (\$2.50 annually). The cash dividend will be paid on December 13, 2021 to holders of record as of November 29, 2021. This is the 38th consecutive annual increase in the dividend paid by Atmos Energy Corporation.

Atmos Energy Corporation, an S&P 500 company headquartered in Dallas, is the country's largest natural gas-only distributor. Atmos safely delivers reliable, affordable, efficient and abundant natural gas to more than 3 million distribution customers in over 1,400 communities across eight states located primarily in the South. As part of the company's vision to be the safest provider of natural gas services, it is modernizing its business and infrastructure while continuing to invest in safety, innovation, environmental sustainability and its communities. Atmos Energy manages proprietary pipeline and storage assets, including one of the largest intrastate natural gas pipeline systems in Texas.

Atmos Energy Corporation is in the Utilities sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 42 of 49 companies in our Core Rising Dividend portfolio have announced 47 dividend increases averaging about 9.4% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
