Another Dearborn Partners Core Rising Dividend SMA Portfolio Increase: Mastercard Incorporated

On November 30, 2021, Mastercard Incorporated (MA) announced an 11.4% increase in its quarterly dividend per share to \$0.49 (\$1.96 annually) from \$0.44 (\$1.76 annually). The cash dividend will be paid on February 9, 2022 to holders of record as of January 7, 2022. This is the 11th consecutive annual increase in the dividend paid by Mastercard Incorporated.

Mastercard is a global technology company in the payments industry. Its mission is to connect and power an inclusive, digital economy that benefits everyone, everywhere by making transactions safe, simple, smart and accessible. Using secure data and networks, partnerships and passion, its innovations and solutions help individuals, financial institutions, governments and businesses realize their greatest potential. With connections across more than 210 countries and territories, Mastercard is building a sustainable world that unlocks priceless possibilities for all.

Mastercard Incorporated is in the Information Technology sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 44 of 49 companies in our Core Rising Dividend portfolio have announced 49 dividend increases averaging about 9.6% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
