On January 18, 2022, Fastenal Company announced a 10.7% increase in its quarterly dividend per share to \$0.31 (\$1.24 annually) from \$0.28 (\$1.12 annually). The cash dividend will be paid on March 2, 2022 to holders of record as of February 2, 2022. This is the 23rd consecutive annual increase in the dividend paid by Fastenal Company.

In our High & Rising Dividend Portfolio, 1 of 25 companies have announced 1 dividend increases averaging about 10.7% more than these companies paid a year earlier. No companies in these portfolios have reduced or suspended dividends so far this year.
