Another Dearborn Partners Core Rising Dividend SMA Portfolio Increase: Costco Wholesale Corporation

On April 13, 2022, Costco Wholesale Corporation (COST) announced a 13.9% increase in its quarterly dividend per share to \$0.90 (\$3.60 annually) from \$0.79 (\$3.16 annually). The cash dividend will be paid on May 13, 2022 to holders of record as of April 29, 2022. This is the 19th consecutive annual increase in the dividend paid by Costco Wholesale Corporation.

Costco currently operates 829 warehouses, including 573 in the United States and Puerto Rico, 105 in Canada, 40 in Mexico, 30 in Japan, 29 in the United Kingdom, 16 in Korea, 14 in Taiwan, 13 in Australia, four in Spain, two each in France and China, and one in Iceland. Costco also operates e-commerce sites in the U.S., Canada, the United Kingdom, Mexico, Korea, Taiwan, Japan, and Australia.

Costco Wholesale Corporation is in the Consumer Staples sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 21 of 49 companies in our Core Rising Dividend portfolio have announced 21 dividend increases averaging about 13.9% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
