Another Double-Digit Dearborn Partners Core Rising Dividend SMA Portfolio Increase: Intuit Inc.

On August 23, 2022, Intuit Inc. (INTU) announced a 14.7% increase in its quarterly dividend per share to \$0.78 (\$3.12 annually) from \$0.68 (\$2.72 annually). The cash dividend will be paid on October 18, 2022. This is the 11<sup>th</sup> consecutive annual increase in the dividend paid by Intuit Inc.

"We had a very strong fourth quarter, ending the year with momentum. We're more confident than ever in our long-term business strategy as we power prosperity around the world," said Sasan Goodarzi, Intuit's chief executive officer. "Our platform and offerings are mission-critical for consumers and small businesses, and we are proud that Intuit is the platform of choice for over 100 million customers around the world."

Intuit is the global technology platform that helps consumers and small businesses overcome their most important financial challenges. Serving more than 100 million customers worldwide with TurboTax, QuickBooks, Mint, Credit Karma, and Mailchimp, we believe that everyone should have the opportunity to prosper. We never stop working to find new, innovative ways to make that possible.

Intuit Inc. is in the Information Technology sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 30 of 49 companies in our Core Rising Dividend portfolio have announced 31 dividend increases averaging about 12.7% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
