Another Dearborn Partners Core Rising and High & Rising Dividend SMA Portfolio Increase: Republic Services, Inc.

On July 29, 2022, Republic Services, Inc. (RSG) announced a 7.6% increase in its quarterly dividend per share to \$0.495 (\$1.98 annually) from \$0.46 (\$1.84 annually). The cash dividend will be paid on October 14, 2022 to holders of record as of October 3, 2022.

From the press release: "We are raising our quarterly dividend by approximately 8 percent," said Jon Vander Ark, president and chief executive officer. "This is the nineteenth consecutive year we've increased our annual dividend, which demonstrates our commitment to efficiently return cash to shareholders."

Republic Services, Inc. is a leader in the U.S. environmental services industry. Through its subsidiaries, the Company provides superior service offerings while partnering with customers to create a more sustainable world.

Republic Services, Inc. is in the Industrials sector of both of our Dearborn Partners Rising Dividend separately managed account (SMA) portfolios. So far this year, 27 of 49 companies in our Core Rising Dividend portfolio have announced 28 dividend increases averaging about 12.8% more than these companies paid a year earlier. In our High & Rising Dividend Portfolio, 15 of 25 companies have announced 16 dividend increases averaging about 8.5% more than these companies paid a year earlier. No companies in these portfolios have reduced or suspended dividends so far this year.
