Another Dearborn Partners Core Rising Dividend SMA Portfolio Increase: Microsoft Corp.

On September 20, 2022, Microsoft Corp. announced a 9.7% increase in its quarterly dividend per share to \$0.68 (\$2.72 annually) from \$0.62 (\$2.48 annually). The cash dividend will be paid on December 8, 2022 to shareholders of record as of November 17, 2022. This is the 17th consecutive annual increase in the dividend paid by Microsoft Corp.

From the press release: Microsoft is among the largest U.S. dividend payers, with cash payouts topping \$18 billion for its most recent fiscal year ended June 30.

Microsoft Corp. is in the Information Technology sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 32 of 49 companies in our Core Rising Dividend portfolio have announced 33 dividend increases averaging about 12.3% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
