Another Dearborn Partners High & Rising Dividend SMA Portfolio Increase: Realty Income Corporation

On September 13, 2022, after only one quarter, Realty Income Corporation announced an increase in the Company's common stock monthly cash dividend per share to \$0.248 (\$2.976 annualized) to be paid October 14, 2022 to shareholders of record as of October 3, 2022. This newly declared dividend is up 0.2% from the \$0.2475 (\$2.97 annualized) paid last quarter, and up 5.1% from \$0.236 (\$2.832 annualized) paid in September 2021.

From the press release: "I'm pleased that Realty Income can once again increase the amount of the monthly dividend," said Sumit Roy, President and Chief Executive Officer of Realty Income. "Today's dividend declaration represents the 100th consecutive quarterly dividend increase and the 627th consecutive monthly dividend throughout our 53-year operating history."

Realty Income, The Monthly Dividend Company®, is an S&P 500 company and member of the S&P 500 Dividend Aristocrats® index. We invest in people and places to deliver dependable monthly dividends that increase over time. The company is structured as a REIT, and its monthly dividends are supported by the cash flow from over 11,400 real estate properties owned under long-term net lease agreements with commercial clients. To date, the company has declared 627 consecutive common stock monthly dividends throughout its 53-year operating history and increased the dividend 117 times since Realty Income's public listing in 1994 (NYSE: O).

Realty Income Corporation is in the Real Estate sector of our Dearborn Partners High & Rising Dividend separately managed account (SMA) portfolio. So far this year, 16 of 25 companies in our High & Rising Dividend portfolio have announced 18 dividend increases averaging about 8.1% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
