Another Double-Digit Dearborn Partners Core Rising Dividend SMA Portfolio Increase: American Tower Corporation

On December 8, 2022, American Tower Corporation (AMT) announced an increase in the Company's quarterly cash dividend per share to \$1.56 (\$6.24 annually) up 6.1% from the \$1.47 (\$5.88 annualized) paid last quarter, and up 12.2% from the \$1.39 (\$5.56 annually) paid a year earlier. The cash dividend will be paid on February 2, 2023 to holders of record as of December 28, 2022. This is the 10th consecutive annual increase in the dividend paid by American Tower Corporation.

American Tower, one of the largest global REITs, is a leading independent owner, operator, and developer of multitenant communications real estate with a portfolio of approximately 223,000 communications sites and a highly interconnected footprint of U.S. data center facilities.

American Tower Corporation is in the Real Estate sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 46 of 49 companies in our Core Rising Dividend portfolio have announced 50 dividend increases averaging about 12% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
