

Another Dearborn Partners High & Rising Dividend SMA Portfolio Increase: Realty Income Corporation

On September 12, 2023, after only one quarter, Realty Income Corporation announced an increase in the Company's common stock monthly cash dividend per share to \$0.256 (\$3.072 annualized) to be paid October 13, 2023 to shareholders of record as of October 2, 2023. This newly declared dividend is up 0.2% from the \$0.2555 (\$3.066 annualized) paid last quarter, and up 3.2% from \$0.248 (\$2.976 annualized) paid in October 2022.

From the press release: "Core to Realty Income's mission is providing our stockholders with dependable monthly dividends that increase over time. I'm pleased Realty Income will once again increase our monthly dividend for the 104th consecutive quarter," said Sumit Roy, President and Chief Executive Officer of Realty Income. "With the payment of our 639th consecutive monthly dividend in October, we remain committed to this goal."

Realty Income, The Monthly Dividend Company®, is an S&P 500 company and member of the S&P 500 Dividend Aristocrats® index. We invest in people and places to deliver dependable monthly dividends that increase over time. The company is structured as a REIT, and its monthly dividends are supported by the cash flow from over 13,100 real estate properties primarily owned under long-term net lease agreements with commercial clients. To date, the company has declared 639 consecutive monthly dividends on its shares of common stock throughout its 54-year operating history and increased the dividend 122 times since Realty Income's public listing in 1994 (NYSE: O).

Realty Income Corporation is in the Real Estate sector of our Dearborn Partners High & Rising Dividend separately managed account (SMA) portfolio. So far this year, 16 of 25 companies in our High & Rising Dividend portfolio have announced 19 dividend increases averaging about 6.1% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
