Another Dearborn Partners Core Rising Dividend SMA Portfolio Increase: Arthur J. Gallagher & Co.

On January 24, 2024, Arthur J. Gallagher & Co. announced a 9.1% increase in its quarterly dividend per share to \$0.60 (\$2.40 annually) from \$0.55 (\$2.20 annually). The cash dividend will be paid on March 15, 2024 to holders of record as of March 1, 2024. This is the 14<sup>th</sup> consecutive annual increase in the dividend paid by Arthur J. Gallagher & Co.

Arthur J. Gallagher & Co. (NYSE:AJG), a global insurance brokerage, risk management and consulting services firm, is headquartered in Rolling Meadows, Illinois. Gallagher provides these services in approximately 130 countries around the world through its owned operations and a network of correspondent brokers and consultants.

Arthur J. Gallagher & Co. is in the Financials sector of our Dearborn Partners Core Rising Dividend separately managed account (SMA) portfolio. So far this year, 5 of 49 companies in our Core Rising Dividend portfolio have announced 5 dividend increases averaging about 6.8% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
