A Double-Digit Dearborn Partners Core Rising Dividend SMA Portfolio Increase to Help Make This a Happy Valentine's Day: Sherwin Williams Company

On February 14, 2024, Sherwin Williams Company announced an 18.2% increase in its quarterly dividend per share to \$0.715 (\$2.86 annually) from \$0.605 (\$2.42 annually). The cash dividend will be paid on March 8, 2024 to holders of record as of February 26, 2024. This is the 46th consecutive annual increase in the dividend paid by Sherwin Williams Company.

With global headquarters in Cleveland, Ohio, Sherwin-Williams® branded products are sold exclusively through a chain of more than 5,000 Company-operated stores and facilities, while the Company's other brands are sold through leading mass merchandisers, home centers, independent paint dealers, hardware stores, automotive retailers, and industrial distributors. The Sherwin-Williams Performance Coatings Group supplies a broad range of highly-engineered solutions for the construction, industrial, packaging and transportation markets in more than 120 countries around the world. Sherwin-Williams shares are traded on the New York Stock Exchange (symbol: SHW).

So far this year, 12 of 49 companies in our Core Rising Dividend portfolio have announced 12 dividend increases averaging about 6.6% more than these companies paid a year earlier. No companies in this portfolio have reduced or suspended dividends so far this year.
